# **New Ordinances Regulate Lawn Watering**

Beginning June 1, 2002, new ordinances take effect in the City of Dallas regarding lawn and landscape watering. Under the new ordinances, it is an offense to water a lawn or landscape in a manner that wastes water or causes runoff. A person commits an offense if violations occur on property that he owns, leases or manages.

Watering of lawns or landscapes is prohibited between the hours of 10:00 a.m. and 6:00 p.m., from June 1 – September 30 of any year. Violations

of the new outdoor watering restrictions will result in a fine of not less than \$250 or not more than \$2,000.

When watering lawns or landscapes, residents should not cause water to fall on sidewalks, driveways or other areas that are not lawns or landscapes. It is also a violation to operate an irrigation system with broken or missing sprinkler heads or one that is poorly maintained and leads to water waste. In addition, lawns or landscapes should not be

watered or irrigated during any form of precipitation.

Any new irrigation system installed must be equipped with working rain-sensing devices and freeze sensors. In addition, by 2005, all preexisting irrigation systems in operation prior to 2002 must be equipped with working rain-sensing devices and freeze sensors.

### FWADG Outlines Six Steps for Improving Fort Worth Ave.

The Fort Worth Avenue Development Group recently recommended six steps to help improve the West Commerce/Fort Worth Avenue corridor. These recommendations were delivered to key elected and appointed leaders who represent northern Oak Cliff.

Following are the group's six recommendations:

- Support a city-lead land use study for the length of the West Commerce/ Fort Worth Avenue corridor and boost that study's priority.
- 2. Support a simultaneous, neighbor-driven land use study to be lead by the Fort Worth Avenue

Development group

- 3. Notify citizens of building permit applications on "at risk" properties.
- 4. Make it a budgetary priority to make building permit applications public, searchable and available via the internet
- 5. As soon as possible, city officials should meet with Family Dollar Store executives to request some concessions in the store's design before construction begins.
- Adopt a 120-day building permit moratorium for businesses engaging in "inside commercial amusement", alcohol-related use, or automobile sales and service.

The group has asked Councilperson Mark Housewright to champion these action steps and invites residents to encourage Mr. Housewright to aggressively and publicly support them. # **Prevention of Animal Cruelty Month**

April is "Prevention of Animal Cruelty Month" and the City of Dallas has joined other animal control agencies and animal welfare groups in stepping up its efforts to encourage citizens to report incidents of animal abuse.

"It's important that people realize there is something they can do to stop animal cruelty," said Sam Rice, manager of Dallas Animal Control. "Because of all the recent publicity surrounding animal cruelty cases in Texas, people have been willing to come forward and contact authorities."

Rice joined members of the Dallas Animal Shelter Commission in emphasizing that animal cruelty is a crime. They urged residents to call 3-1-1 to report animal abuse and 9-1-1 to report an animal-related emergency.

"We all need to play an active role in stopping animal cruelty," said Fred Brodsky, chairman of the Animal Shelter Commission. "Everyone on the commission and the animal control staff urges Dallas residents to be alert to potential animal abuse, and to report these incidents as soon as possible."

Last year Texas joined a growing number of states in changing animal cruelty from a misdemeanor to a felony, punishable by up to \$2,000 in fines and/or up to one year in jail.
